





Year in Retrospect

The year 2021-2022 has been a positive one, basis on our past interventions and challenges from them. When the world was precarious and almost stanstill during Covid-19 Pendemic, our passion for Road Safety kept us going steadily.

During this period, we focussed on 'Safe Road Design Interventions' along with sensitization and dissemination of Road Safety aspects through online Capacity Building Workshops, Training, Youth Engagement Programs and Safe Infrastructural Interventions.





We partnered with the Hyundai Motor India Foundation's prestigious year-long project 'Dhyan Do' to be implemented in the Gurugram and Faridabad districts of Haryana.

TRAX completed its prestigious project 'Road Safety Rangers 2.0 with 'Universal Sompo General Insurance' in Mumbai wherein 3 Mumbai based schoolS were converted into Safe School Zones. We also trained School teachers on the various aspects of Road Safety, engaged the students through various activities and provided Training Material as well.

Project 'SATARK' with Bridgestone Motor India Pvt. Ltd. was also initiated with the aim to propagate a Road Safety Culture through Education, Deliberations and action among young minds in Schools and Colleges located in the city of Hyderabad and Indore through conducting activities and actions by students by engaging the Stakeholders and Community members.





Hero Honda Chowk - Gurugram (Haryana)- This intersection was an identified 'Road Accident Black Spot' by the Ministry of Road Transport and Highways- Govt. of India. TRAX undertook the Safe Road Design Intervention at this Intersection. Involving the concerned stakeholders, we began the work with the Road Audit, identified the flaws in its infrastructural design, implemented the remedial measures, and achieved the goal of converting this intersection into a 'Zero Fatality Zone'.

Interventions and Projects By TRAX 2021 & 2022

















Pillar 1 - Road Safety Management

The Decade of Action 2021-2030 recognizes that road transport is a complex system and places safety at its core. It also recognizes that humans, vehicles and the road infrastructure must interact in a way that ensures a high level of safety.

We, while devising our projects, advocacy programs, or ground activation, use government mechanisms by engaging all concerned stakeholders, collecting and analyzing the data derived from the particular action and following a proper reporting system.

TRAX is working in accordance with the Road safety Pillars devised in the Decade of Action 2021-2030. In all our endeavors, we ensure to address such issues where machine-to-human interaction could be safer and a reduced rate of road crashes and fatalities could be achieved as end result.



We have initiated our 'Safe Road Design' intervention program wherein we have successfully converted the Hero Honda (intersection) in Gurugram-Haryana from a Road Accident Black Spot into 'Non-Fatality Zone'. Besides, we have converted a total of 13 schools in Delhi, Mumbai and Gurugram into 'Safe Schools Zones' by implementing the desired road safety measures.

Another such intervention is currently underway at the Rajeev Chowk, Gurugram Haryana wherein the Gurugram Administration, NHAI, GMDA, Traffic and Civil Police and the Transport department are the major stakeholders.

We have been actively participating in the meetings of District Road Safety Committees of different districts of Noida, Delhi and Gurugram, pushing our recommendations and address the Road Safety Issues as per the guidelines suggested under Road Safety Pillars of the Decade of Action 2021-2030.

We are working on the 'Behavioral Aspects' of drivers and road users. We have a team of Counsellors who, in their interactive sessions, interact with the Drivers, understand their psychological issues and provide counselling accordingly.

Pillar 2 - Safe Road Infrastructure

1. Rajeev Chowk - Gurugram 3. Safe School Zones in Mumbai & Delhi

2. Hero Honda Intersection 4. Rani Jhansi Road

Safe road infrastructure is essential to reduce road trauma. Road infrastructure must be planned, designed, built and operated to enable multimodal mobility, including shared/public transport, and walking and cycling. It must eliminate or minimize risks for all road users, not just drivers, starting with the most vulnerable.

In accordance with the guidelines laid down under Pillar-5, TRAX identified Rajeev Chowk (Intersection) in the district of Gurugram of Haryana to start its Safe Road Design intervention.

Rajeev Chowk is the biggest and the busiest intersection of the Gurugram. It is situated at the NH-48 and surrounded by important government offices, including the Mini Secretariat and Police Head Quarter. Besides, there are many resedential and industrial establishments around this intersection. Given the current design of the intersection, it is not able to cope-up with the heavy and mixed traffic flow.

The problems identified at this intersection were: multi-lane traffic movement, messy parking of the vehicles due to non-availability of the designated parking area, diagonal approach from Sohna towards Mini Secretariat, lack of pedestrian facilities, absence of Traffic Lights and confusion among the road users due to its two-sided diagonal approach and confusing U-Turns, etc.

TRAX submitted a 'Safe Road Design' of this intersection and presented it to the concerened stakeholders during the meeting of the District Road Safety Committee for their approval. After the design was approved, a trial run of the same started on 26.03.2022.

During the trial run, we reduced multi-lanes to 3-4 lanes with cones, bollards, crash barriers, etc. to ensure proper channelization of the traffic. The traffic movement from all directions was constantly reviewed and changes, as per the practical experience were made. Traffic Lights were also installed at the intersection.

The process to build a permanent structure along with the beautification of the intersection is in process and soon will be a reality.



Hero Honda Chowk- Gurugram From 'Road Accident Black-Spot' To A 'Zero Fatality Zone'


The Hero Honda Chowk in Gurugram District of Haryana is an identified 'Road Accident Black Spot' by the National Highways Authority of India. TRAX started its Safe Road Design Intervention at the Hero Honda Chowk in Sep'2020 with a road audit and identified the gap areas related to its design along with other factors. The Safe Road Design implementation work finished in March'2021. To evaluate the impact, we cross-checked the road accident data with the concerned stakeholders for the year 2019-2021.

The record shared by them, clearly revealed that there's been zero deaths post 'Safe Road Design Intervention' (March'2021 till March'2022).

The Team TRAX successfully created the safe design of this intersection with the thorough involvement in this project that resulted in a success story.

We are thankful to the National Highway Authorities of India, 'Safer Roads for Gurugram Initiative' District Administration Gurugram for their valuable support.





Teacher Training Program on Road Safety and Importance of Safe School Zone

Road Safety Rangers 2.0 was completed in 3 phases, Selection/Audit, Safe School Zone Development, and Developing Road Safety Culture through training of Teachers, to instil Road Safety values in students and their parents by trained Teachers.

The training session was very interactive and feedback from teachers was really encouraging.

This campaign is itself an example of Self-Sustainability under which three vulnerable schools have been converted into Safe School Zone, Road Safety messages have reached to more than 6000 students and their parents through trained teachers. Banners provided and fixed within the premises of schools which will recall road safety values every day to the students, parents and school administration.





Pillar 4 - Safer Road Users

Pillar 4 emphasizes the need of developing Standard Training, Awareness Raising Methods, Drivers Authorization Methods and Develop an Enforcement Mechanism.

The Safety of Road Users is much dependent on their Behaviour on Roads. The need is to understand the influencing factors behind such behavior and devise the countermeasures to address this situation.

We are of the opinion that the Road Safety Education must start from the early years. It becomes more important in case of the India, which leads the world in Road Crashes with 11% global accident share.

TRAX devises its programs, projects and activities in a way that helps to address this situation in a sustainable manner.



World Day of Rememberance

The 'World Day of Remembrance for Road Traffic Victims also known as WDoR' is observed globally every year on the 3rd Sunday in the Month of November. TRAX has been observing WDoR for road traffic victims for the last seven years.

TRAX commemorated WDoR 2022 in association with Gautam Budh Nagar Traffic Police at their Headquarter. On the occasion, candles were lit in the memory of Road Traffic Victims who died in the district in 2021. The program witnessed the presence of some prominent citizens, Senior Officials from Traffic Police along with locals. Ms. Sunita and Mr. Vijay Nand represented TRAX in the activity. The gathering was addressed by the prominent guests who urged and encouraged the gathering to be a Safe and Smart Road User. Parents, Teachers, and Traffic Police Personnel were also appealed to be a Role Model for their children and the society at large.





Advocacy Programs By TRAX During 2021-2022

Media Content Regulation Program - MCRP

In view of the potential impacts of media contents on human psychology, the program insists on the need to make policies to regulate those media depictions in Movies and Television Commercial that defy Road Traffic Rules laid down in the Motor Vehicle Act - 1988.

India being the largest producer of Movies and the second-largest consumer market in the world, is a hub of the commercial activities of national and international brands. Brands mainly rely on their aggressive advertising strategies. Advertisements are for sure helpful in creating an image for brands in consumers' minds but we observed that these brands often defy Road Traffic Rules with ease as there are neither strict policies to curb such depictions nor there's any government body with legislative powers that monitor and regulate such depictions.

Basis this, TRAX submitted its recommendation to the 'Supreme Court Committee on Road Safety constituted in 2014. The Committee called a meeting to discuss the matter to take some concrete action in this regard wherein Advertising Standard Council of India (ASCI), Society of Indian Automobile Manufacturers (SIAM), Ministry of Road Transport & Highways (MoRTH), Censor Board, PIB, and Ministry of I&B were invited as the main Stakehold-

The Committee directed the SIAM and ASCI to make guidelines ensuring the safety of Road Users. ASCI introduced its guidelines on Road Safety. These guidelines had loopholes as ASCI didn't specify related sections of the Motor Vehicle Act-1988 and punishment associated with them.

We've been closely observing and monitoring cases; where despite ASCI's stopping the broadcasting of the concerned TVC/Movie Scene, such TVC's/Movie Scenes are being broadcasted openly. We have put up this matter with the Ministry of Information & Broadcasting, MoRTH, and Censor Board of India and constantly pursuing the matter with them.

Meanwhile, we've intervened with the ASCI for a number of TVCs which we found defying the Road Traffic Rules and have been successful in stopping their further broadcast.






Advocacy Campaigns By TRAX During 2021-2022

Helmet India Coalition

India contributes around 11% of the worlds' road accidents, through it has only 1% vehicular population of the world. This costs India approx 3% annual GDP loss. The most affected age group is 18-45 years having 70% of total road accident deaths. Out of total road accident deaths, the motorized two-wheeler riders are the worst affected category. Most of the deaths in this category happen due to the Non - Wearing of Helmet or wearing a Poor Quality Helmet.

During 2021-2022, we have successfully added up 16 states and 1 UT (J&K) under our Helmet Advocacy Program. We are determined to promote the 'Safe Helmet Wearing' as a 'Safe Habit' and will surely reach more Stakeholders in the rest of the States and UTs this year.


